- iii. All the Principals/ Directors are requested to monitor their Office activity through online/ physically accordingly.
- iv. All the Teaching, Non-teaching and Outsourcing staff shall obey the orders of the concerned Principals/ Directors.
- v. All the Teaching, Non-teaching and Outsourcing staff have to follow the guidelines mentioned by the Government vide ref. read above.
